



Mount Pleasant Town Hall Art Program

The Town of Mount Pleasant Culture, Arts & Pride Commission invites artists to submit photos of completed artwork for a four-month rotating display in the hallways of Mount Pleasant Town Hall, located at 100 Ann Edwards Lane.

The objective of this program is to promote an awareness of local artists, encourage interaction within the artist community, and to foster community pride.

Submission Requirements

1. Completed application form.
2. Signed release waiver.
3. Artist bio.
4. Print or photo or digital file (jpg) of each submitted piece of artwork.

Note: Selected individuals must commit their artwork to a 4-month showcase.

Artist Benefits

1. Artist and art name included on information card hung with artwork.
2. Artist's name, artwork title, and photos of the artwork may be included on the Town of Mount Pleasant website and/or social media accounts as well as in press release/program promotions.

Design Specifications

1. Art must be original and wholly the work of the submitting artist.
2. Any medium or mixed medium may be submitted.
3. An artist may submit up to three (3) pieces of artwork for consideration.
4. The overall weight of the artwork including the frame may not exceed 50 pounds.
5. Artwork must be wired for hanging.

Eligibility

1. Artist must be 17 years of age or older.
2. Artist must reside or work in the Town of Mount Pleasant.
3. Artist may not be an employee nor serve on an appointed commission of the Town of Mount Pleasant.



Terms of Agreement

1. The artwork submitted is original, solely owned by the artist, and reproduction will not violate the rights of any third party.
2. The Town of Mount Pleasant retains the right to use accepted artwork presented for this project and to use prints/photos of the art and the artist for promotional material. The Town may not sell the art to a third party for profit. The artist has the right to reproduce his/her art for profit.
3. The Town of Mount Pleasant has the right to remove or replace the art without prior notification to the artist.

Selection process

All entries will be juried by Town of Mount Pleasant staff and the Culture, Arts & Pride Commission. Submitted photos may be utilized for marketing purposes to include website, social media and/or print, and will not be returned; submission of photos indicates your consent for these purposes.
