### November 2017

#### **Revenue Highlights**

1. Business Licenses: Received approximately 85% of annual revenue. (7.3% growth over last year)
2. Public Utilities: Received approximately 96% of annual revenue. (.8% growth over last year)
3. Insurance Licenses: Received approximately 99% of annual revenue. (6.3% growth over last year)
4. Local Option Sales Tax: Received approximately 26% of annual revenue. (1% growth over last year)

#### **Note**

Starting in Fiscal Year 2018, Federal and State Operating Grants are included within the General Fund rather than being held in a separate fund.
